GENERAL DESCRIPTION

The Behavioral Health Integration (BHI) Counselor is responsible for providing behavioral health brief solution focused therapy to clients referred by the medical clinic. The BHI counselor will be located in a Mill Creek medical clinic and our office in Shoreline, WA. They will follow the SBIRT (Screening, Brief Intervention, & Referral to Treatment) model. This is a full-time, non-exempt position, reporting to Behavioral Health Associate Director.

MAJOR RESPONSIBILITIES – Specific for this position

- Integrate behavioral health services with primary care services at locations determined by the agency
- Maintain a client caseload and appropriate clinical records
- Document in CHS's electronic health record
- Provide clinical screenings and full or partial intakes to clients referred by primary care providers (PCPs)
- Provide brief therapy or interventions to referred clients when clinically appropriate
- Use motivational interviewing to help the client accept needed services (medical, mental health, substance use treatment, etc.)
- Make referrals for long-term services or for services not provided by BHI counselor
- Provide necessary case management to clients referred
- Communicate with PCPs regarding patient diagnosis, progress, and referrals to other services in a timely manner
- Actively promote CHS programs to PCP clinic staff, families, and individuals; develop and maintain relationships with community contacts, referral sources, and other professionals and agencies
- Provide outreach and education to community contacts, referral sources, and other service providers
- Sustain billable hours as determined by supervisor
- Participate in program development and evaluation of the BHI program
- Maintain a respectful and courteous attitude toward all community contacts, agency partners, and clients
- Maintain accurate and thorough clinical records as per agency, county, and state requirements
- Provide input and report to leadership regarding the clinical needs of clients, needs of the hosting clinic, and ways to improve services and supervision
- Conduct collaborative documentation with clients during therapy sessions
- Participate in individual supervision, staff meeting, clinical consultations, and all-staff meetings as scheduled.

MAJOR RESPONSIBILITIES – Agency in general

- Provide all services utilizing a strengths-based, family-focused, client-centered, trauma-informed, culturally competent approach that is integrated with other services
- Participate in creating and maintaining a workplace that values diversity and treats everyone with dignity and respect without regard to race, color, age, religion, creed, gender, gender identity, gender expression, sexual orientation, national origin, marital status, the presence of any sensory, mental, or physical disability
- Utilize teamwork and open communication
- Have prompt and consistent attendance during scheduled working hours

- Maintain documentation in a timely, thorough and accurate manner

- One or more years of experience working with youth and adults with behavioral health concerns
- Knowledge of community social services resources and how to access the resources
- Experience with diverse client groups and treatment methodologies
- Experience working with trauma issues preferred
- Excellent organizational/administrative skills
- Solution focused therapy, motivational interviewing or SBIRT experience is a plus.
- Experience working with youth and children
- Articulate with the ability to represent the agency in a professional manner
- Comfort and skill with networking
- Flexible, motivated to achieve goals, and thrives on challenge
- Available to work some evening hours on a regular schedule
- Must have no misuse of alcohol or other drugs within the previous 2 years
