# INTEGRATED MENTAL HEALTH COUNSELOR/THERAPIST

The Behavioral Health (BHI) Therapist is responsible for providing behavioral health assessments and brief therapy to students referred by the medical clinic. The BHI Therapist will be located in the medical clinic and will follow the SBIRT (Screening, Brief Intervention, & Referral to Treatment) model. This is a full-time, non-exempt position; reporting to Behavioral Health Associate Director. Salary range is from \$57,324.80 - \$76,404.22 per year depending on credentials, experience, and licensure.

Job Requirements:

- Master's degree in Counseling or related field preferred
- Bachelor's degree in Counseling or related field with a year of experience required
- Current Agency Affiliated, Associate, or Fully Licensed MSW, MFT or MHC professional in Washington State
- One or more years clinical experience working with children and families
- Valid Washington State Driver's License and reliable transportation
- Ability to provide both mental health and substance use disorders interventions and treatments
- Experience providing SBIRT preferred
- Experience navigating different systems (schools/families)
- Experience working with trauma issues
- Excellent organizational/administrative skills with good computer skills
- Commitment to confronting racism, sexism, heterosexism, and other discriminatory practices
- Ability to work cooperatively as part of a team
- Ability to adapt to change
- Sense of humor.

# <u>Job Description</u> INTEGRATED MENTAL HEALTH COUNSELOR/THERAPIST

#### **GENERAL DESCRIPTION**

The Behavioral Health Therapist is responsible for providing behavioral health assessments and brief therapy to patients referred by specific health care providers. The position will be located at one or more primary care practices and will follow the SBIRT (Screening, Brief Intervention, & Referral to Treatment)



model. The Behavioral Health therapist reports to the Behavioral Health Integration Associate Director. This is a non-exempt position.

### MAJOR RESPONSIBILITIES – Specific for this position

- Integrate behavioral health services with primary care services at locations determined by the agency
- Maintain a client caseload and appropriate clinical records
- Document in both CHS's electronic health record and the hosting clinic's medical record
- Provide clinical screenings and full or partial intakes/assessments to clients referred by primary care providers (PCPs)
- Provide brief therapy or interventions to referred clients when clinically appropriate
- Use motivational interviewing to help the client accept needed services (medical, mental health, substance use treatment, etc.)
- Make referrals for long-term services or for services not provided by BHI
- Provide necessary case management to clients referred
- Communicate with PCPs regarding patient diagnosis, progress, and referrals to other services in a timely manner
- Actively promote CHS programs to PCP clinic staff, families and individuals; develop and maintain relationships with community contacts, referral sources, and other professionals and agencies
- Provide outreach and education to community contacts, referral sources, and other service providers
- Sustain billable hours as determined by supervisor
- Participate in program development and evaluation of the BHI program
- Maintain a respectful and courteous attitude toward all community contacts, agency partners, and clients
- Maintain accurate and thorough clinical records as per agency, county and state requirements
- Provide input and report to leadership regarding the clinical needs of clients, needs of the hosting clinic, and ways to improve services and supervision
- Conduct collaborative documentation with clients during therapy sessions
- Participate in individual supervision, staff meeting, clinical consultations, and all-staff meetings as scheduled

## MAJOR RESPONSIBILITIES – Agency in general

- Provide all services utilizing a strengths-based, family-focused, client-centered, trauma-informed, culturally competent approach that is integrated with other services
- Participate in creating and maintaining a workplace that values diversity and treats everyone with dignity and respect without regard to race, color, age, religion, creed, gender, gender identity, gender expression, sexual orientation, national origin, marital status, the presence of any sensory, mental, or physical disability
- Utilize teamwork and open communication
- Have prompt and consistent attendance during scheduled working hours
